- a) At Merchiston the medium of instruction is English.
- b) Applications for admission to Merchiston are received on or after 1 January of the year preceding the year of admission but not before i.e. maximum advance booking is one year.
- c) Life Skills (including sexuality, aids and religions) is taught as part of the School programme.
- d) Sport and other extra-mural activities including Physical Education are compulsory. Every day boy is required to participate in at least one sport or extra-curricular activity per quarter organised by the School. Boarders are required to participate in two extra-mural activities per quarter.
- e) Educational field trips, tours and excursions are undertaken from time to time and sometimes require that boys sleep out. Boys are expected to attend these outings/excursions. Parents are levied a fee for these trips, tours and excursions.
- f) Admission to Grade One: the admission age for pupils entering Grade One will be in accordance with current legislature.
- g) The Annual Inter House Gala, Athletics Meeting and end of year Prize Giving Ceremony is compulsory (Gr 3 where applicable) Gr 4-7 are all required to attend these functions.
- h) Admissions procedure: Upon receipt of this application, it will be processed and you will be informed timeously whether you and your son are required to attend an interview.
- i) Should you wish to remove your son from either the School or the Boarding Establishment the following notice periods will apply:
  - **REMOVAL FROM SCHOOL - ONE TERMS NOTICE OR 25% OF THE ANNUAL SCHOOL FEES IN LIEU THEREOF.**
  - **REMOVAL FROM THE BOARDING ESTABLISHMENT - ONE TERM'S NOTICE OR ONE TERM'S BOARDING FEES IN LIEU THEREOF.**

- ii. Merchiston Preparatory School accepts responsibility for my/our son from 07h20 to close of school, or to the end of Sport. In the event of my/our son not being collected at the stipulated time, he will automatically be taken to the Aftercare facility and I/we will be held liable for the hourly charges until he is collected.
- iii. The School levies fees for the purpose of financing costs not borne by the State, extra-curricular activities and to provide amenities for pupils at the School.
- iv. I/we shall pay the fees as levied by the School, on the conditions set out in terms of Sections 39 and 40 of SA Schools Act No 84 of 1996.
- v. I/we acknowledge and accept that while Merchiston Preparatory School is a nondenominational School where members of all faiths are welcome, it is established on Christian principles, a Christian ethos prevails and pupils are required to attend appropriate functions.
- vi. I/we undertake to have my/our son's hair cut regularly in accordance with the standard required by the School and I/we consent to having my/our son's/ward's hair cut by the School barber if he does not comply with the hairstyle and length of hair as required by the School. The cost of which will be charged to my/our account.
- vii. I/we will incur costs for damages done or losses caused by my child/ward to School or State property/equipment.
